

LOTOS EUROS OPEN SOURCE LICENSE

General

TNO operates this website and offers a license for the Lotos-Euros software. TNO is the 'Netherlands Organization for Applied Scientific Research, TNO', an organization duly organized and existing under the laws of the Netherlands and having its registered seat and principal place of business at The Hague, the Netherlands, hereinafter referred to as "LICENSOR" or "TNO", registered at the Dutch Chamber of Commerce under number 27376655.
